1. Rochefort thanked Becky and staff for getting all the information together for the work study. He also suggested that the new members of council should get a tour of all the city buildings.
2. Klaska wanted to assure the community that everyone on council is reviewing all the topics and information prior to all meetings.
3. Kerr questioned whether there could be a, 'No Parking' sign on the road in front of Ordus Ford. She stated that oncoming traffic cannot be seen when cars are parked there.
4. Rapson wanted to tell everyone to 'Stay Warm.'
5. Robinson stated that we have a good board here, with a lot of information to provide, and that he's happy with that.
6. Harrison would like to receive a wage/budget breakdown for everyone on council to review.
7. City Manager Bachman stated that there is a person who has purchased property at the end of Cleveland Street and the person would like to develop the land and build 3 homes. He would like to have the water main/sewer extended to Cleveland for the homes and he is wondering if the city would pay for the extension. Everyone agreed that there would need to be cost estimates by an engineer before further review.  
City Manager Bachman also wanted to let the community know that the radio station is stating that people should run their water so that their pipes will not freeze. This is not the City of Bad Axe's request, and there will NOT be reimbursement for people running their water.
